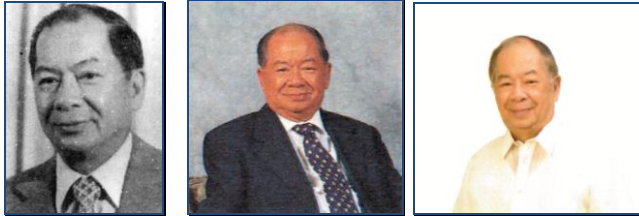




Gabriel C. Singson



Gabriel C. Singson (1929-2016)



Finished his LL. B. (*cum laude*) at the Ateneo de Manila University in 1952; second place, 1952 Bar exams; earned his LL.M. from the University of Michigan Law School in 1960; and DeWitt Fellow, University of Michigan, Fulbright and Central Bank all in 1959-1960

Associate attorney, law office of Justice Jose P. Bengzon, from 1952 to 1955

Legal and evaluation officer, Central Bank from 1955 to 1960

Technical assistant to CB deputy governor from 1963 to 1966 and from 1968 to 1970

Legal officer, Asian Development Bank from 1967 to 1968

Assistant to CB governor from 1970 to 1973; Special Assistant to CB governor (in charge of international operations sector from 1973 to 1974; General Counsel, Central Bank from 1974 to 1975; and Deputy Governor and General Counsel, 1975 to 1980

President, Philippine National Bank from 1992 to 1993

Governor, Bangko Sentral ng Pilipinas from 1993 to 1999

Governor of the IMF for the Philippines and Alternate Governor of the International Bank for Reconstruction and Development (World Bank) and the ADB from 1993 to 1999

Chairman, Great Pacific Life Assurance Corp. from 1999 to 2011

Chairman, Advisory Board of Rizal Commercial Banking Corp. from 2010 to 2016



Gabriel C. Singson had been with the Central Bank (now Bangko Sentral ng Pilipinas) since 1955, where he rose through the ranks to become Senior Deputy Governor prior to being President of the Philippine National Bank in 1992.
